Eight special cases of this equation which are solvable in closed form are developed with detailed examples. Next the resolution of the octal (eighth degree) polynomial equation is developed along with twelve special cases which are solvable in closed form. This book is appropriate for students at the advanced college algebra level who have an understanding of the basic arithmetic of the complex numbers and know how to use a calculator which handles complex numbers directly.
