UNDERSTANDING THE 2017 BUSINESS MILEAGE RATE

THE IRS ESTABLISHED THE 2017 BUSINESS MILEAGE RATE TO HELP TAXPAYERS CALCULATE THEIR VEHICLE-RELATED EXPENSES WHEN USING THEIR CAR FOR BUSINESS PURPOSES. IN 2017, THE STANDARD MILEAGE RATE WAS SET AT 53.5 CENTS PER MILE DRIVEN FOR BUSINESS USE. THIS FIGURE IS DETERMINED BASED ON VARIOUS FACTORS, INCLUDING THE COSTS OF OPERATING A VEHICLE, FUEL PRICES, AND VEHICLE DEPRECIATION.

THE IRS UPDATES THE MILEAGE DEDUCTION RATES ANNUALLY, REFLECTING CHANGES IN THE ECONOMY AND VEHICLE OPERATING COSTS. THEREFORE, IT IS ESSENTIAL FOR TAXPAYERS TO BE AWARE OF THESE RATES AND TO APPLY THEM CORRECTLY TO MAXIMIZE THEIR DEDUCTIONS. THE 2017 RATE WAS A SLIGHT DECREASE FROM THE 54 CENTS PER MILE ALLOWED IN 2016, INDICATING A REDUCTION IN FUEL PRICES AND OVERALL VEHICLE OPERATING COSTS.

APPLICATION OF THE MILEAGE RATE

THE APPLICATION OF THE 2017 BUSINESS MILEAGE RATE IS STRAIGHTFORWARD BUT REQUIRES CAREFUL TRACKING OF MILES DRIVEN FOR BUSINESS PURPOSES. TAXPAYERS CAN USE THE STANDARD MILEAGE RATE FOR VARIOUS BUSINESS-RELATED DRIVING ACTIVITIES, INCLUDING:

- TRAVELING TO MEET CLIENTS OR CUSTOMERS
- ATTENDING BUSINESS MEETINGS OR CONFERENCES
- VISITING JOB SITES OR BUSINESS LOCATIONS
- DRIVING BETWEEN MULTIPLE BUSINESS LOCATIONS

TO APPLY THE MILEAGE RATE, TAXPAYERS SIMPLY MULTIPLY THE TOTAL BUSINESS MILES DRIVEN BY THE STANDARD RATE OF 53.5 CENTS. FOR EXAMPLE, IF A BUSINESS OWNER DROVE 1,000 MILES FOR BUSINESS IN 2017, THE DEDUCTION WOULD AMOUNT TO \$535. HOWEVER, IT IS CRUCIAL TO DIFFERENTIATE BETWEEN BUSINESS AND PERSONAL MILES, AS ONLY BUSINESS-RELATED MILEAGE QUALIFIES FOR DEDUCTIONS.

DIFFERENCE BETWEEN BUSINESS AND PERSONAL MILEAGE

UNDERSTANDING THE DIFFERENCE BETWEEN BUSINESS AND PERSONAL MILEAGE IS VITAL FOR ACCURATE TAX REPORTING. BUSINESS MILEAGE REFERS TO ANY MILES DRIVEN IN A VEHICLE FOR BUSINESS-RELATED PURPOSES, WHILE PERSONAL MILEAGE INCLUDES ANY MILES DRIVEN FOR PERSONAL USE, SUCH AS COMMUTING TO WORK OR RUNNING PERSONAL ERRANDS.

THE IRS HAS SPECIFIC GUIDELINES TO HELP TAXPAYERS DETERMINE WHAT CONSTITUTES BUSINESS MILEAGE. COMMON EXAMPLES OF BUSINESS MILEAGE INCLUDE:

- TRAVELING TO A CLIENT MEETING
- DELIVERING GOODS OR SERVICES
- DRIVING TO A BUSINESS-RELATED SEMINAR

ON THE OTHER HAND, PERSONAL MILEAGE EXAMPLES INCLUDE:

- COMMUTING TO AND FROM A REGULAR WORKPLACE
- RUNNING PERSONAL ERRANDS
- TRAVELING FOR LEISURE OR VACATION PURPOSES

TAXPAYERS MUST MAINTAIN ACCURATE RECORDS TO DISTINGUISH BETWEEN THESE TWO TYPES OF MILEAGE EFFECTIVELY. ONLY THE MILEAGE DRIVEN FOR BUSINESS PURPOSES CAN BE DEDUCTED ON TAX RETURNS.

RECORD KEEPING FOR MILEAGE DEDUCTIONS

ACCURATE RECORD-KEEPING IS ESSENTIAL FOR CLAIMING MILEAGE DEDUCTIONS. THE IRS REQUIRES TAXPAYERS TO MAINTAIN DETAILED RECORDS OF THEIR BUSINESS MILEAGE TO SUBSTANTIATE THEIR CLAIMS. THIS INCLUDES DOCUMENTING THE FOLLOWING INFORMATION:

- DATE OF TRAVEL
- STARTING AND ENDING ODOMETER READINGS
- PURPOSE OF THE TRIP
- NUMBER OF MILES DRIVEN

- LOCATIONS VISITED

TAXPAYERS CAN USE A MILEAGE LOG, WHETHER IN A PHYSICAL NOTEBOOK OR A DIGITAL APPLICATION, TO TRACK THIS INFORMATION. REGULARLY UPDATING AND MAINTAINING THIS LOG WILL ENSURE THAT ALL NECESSARY DETAILS ARE CAPTURED AND ORGANIZED FOR TAX REPORTING PURPOSES.

STANDARD MILEAGE RATE VS. ACTUAL EXPENSES

TAXPAYERS HAVE THE OPTION TO CHOOSE BETWEEN THE STANDARD MILEAGE RATE AND ACTUAL EXPENSES TO CALCULATE THEIR VEHICLE DEDUCTIONS. THE STANDARD MILEAGE RATE PROVIDES A SIMPLIFIED METHOD OF CALCULATING DEDUCTIONS, WHILE THE ACTUAL EXPENSE METHOD REQUIRES MORE DETAILED ACCOUNTING OF ALL VEHICLE-RELATED EXPENSES.

THE ACTUAL EXPENSE METHOD ALLOWS TAXPAYERS TO DEDUCT EXPENSES SUCH AS:

- FUEL COSTS
- REPAIRS AND MAINTENANCE
- INSURANCE
- REGISTRATION FEES
- DEPRECIATION ON THE VEHICLE

TO DETERMINE WHICH METHOD IS MORE ADVANTAGEOUS, TAXPAYERS SHOULD COMPARE THE TOTAL OF THEIR ACTUAL EXPENSES WITH THE DEDUCTION CALCULATED USING THE STANDARD MILEAGE RATE. IN MANY CASES, THE STANDARD MILEAGE RATE MAY YIELD A HIGHER DEDUCTION, BUT THIS CAN VARY BASED ON INDIVIDUAL CIRCUMSTANCES.

IMPLICATIONS OF THE MILEAGE RATE ON TAX RETURNS

Q: CAN I DEDUCT MILEAGE FOR COMMUTING TO MY REGULAR WORKPLACE?

A: NO, COMMUTING TO AND FROM YOUR REGULAR WORKPLACE IS CONSIDERED PERSONAL MILEAGE AND IS NOT DEDUCTIBLE. ONLY MILEAGE DRIVEN FOR BUSINESS-RELATED PURPOSES QUALIFIES FOR DEDUCTIONS.

Q: WHAT RECORDS DO I NEED TO KEEP FOR MILEAGE DEDUCTIONS?

A: YOU NEED TO KEEP RECORDS THAT INCLUDE THE DATE OF TRAVEL, STARTING AND ENDING ODOMETER READINGS, THE PURPOSE OF THE TRIP, NUMBER OF MILES DRIVEN, AND LOCATIONS VISITED TO SUBSTANTIATE YOUR MILEAGE DEDUCTIONS.

Q: SHOULD I USE THE STANDARD MILEAGE RATE OR ACTUAL EXPENSES FOR DEDUCTIONS?

A: THE CHOICE BETWEEN THE STANDARD MILEAGE RATE AND ACTUAL EXPENSES DEPENDS ON WHICH METHOD PROVIDES A LARGER DEDUCTION FOR YOU. IT'S ADVISABLE TO CALCULATE BOTH METHODS TO DETERMINE WHICH IS MORE BENEFICIAL.

Q: WHAT HAPPENS IF I DON'T KEEP ACCURATE MILEAGE RECORDS?

A: IF YOU DO NOT KEEP ACCURATE MILEAGE RECORDS, YOU MAY NOT BE ABLE TO SUBSTANTIATE YOUR MILEAGE DEDUCTIONS DURING AN IRS AUDIT, WHICH COULD LEAD TO PENALTIES OR DISALLOWED DEDUCTIONS.

Q: CAN I SWITCH BETWEEN THE STANDARD MILEAGE RATE AND ACTUAL EXPENSES IN DIFFERENT YEARS?

A: YES, YOU CAN SWITCH BETWEEN THE STANDARD MILEAGE RATE AND ACTUAL EXPENSES IN DIFFERENT TAX YEARS, BUT YOU MUST ADHERE TO SPECIFIC IRS GUIDELINES REGARDING THE METHOD YOU CHOOSE FOR THE VEHICLE IN QUESTION.

Q: ARE THERE ANY CHANGES TO THE MILEAGE RATE FOR 2018?

A: YES, THE IRS TYPICALLY UPDATES THE MILEAGE RATE ANNUALLY. TAXPAYERS SHOULD CHECK THE IRS GUIDELINES FOR THE SPECIFIC MILEAGE RATE APPLICABLE FOR 2018 AND SUBSEQUENT YEARS.
