UNDERSTANDING BUSINESS LICENSES IN ALASKA

IN ALASKA, A BUSINESS LICENSE IS A REQUIREMENT FOR ANYONE WISHING TO OPERATE A BUSINESS WITHIN THE STATE. PROFESSIONAL LICENSES

CERTAIN PROFESSIONS IN ALASKA REQUIRE SPECIFIC LICENSING BEYOND THE GENERAL BUSINESS LICENSE. THESE PROFESSIONALS INCLUDE, BUT ARE NOT LIMITED TO:

- ACCOUNTANTS
- MEDICAL PROFESSIONALS
- REAL ESTATE AGENTS
- CONTRACTORS
- COSMETOLOGISTS

EACH OF THESE PROFESSIONS HAS ITS OWN REGULATORY BOARD, AND ADDITIONAL REQUIREMENTS, SUCH AS EXAMINATIONS AND CONTINUING EDUCATION, MAY BE MANDATED.

SPECIAL PERMITS AND LICENSES

IN ADDITION TO GENERAL AND PROFESSIONAL LICENSES, CERTAIN BUSINESSES MAY NEED SPECIAL PERMITS DEPENDING ON THEIR INDUSTRY. EXAMPLES INCLUDE:

- ALCOHOL LICENSES FOR ESTABLISHMENTS SERVING ALCOHOLIC BEVERAGES
- FOOD SERVICE PERMITS FOR RESTAURANTS AND FOOD TRUCKS
- ENVIRONMENTAL PERMITS FOR BUSINESSES IMPACTING NATURAL RESOURCES

IT IS CRUCIAL FOR BUSINESS OWNERS TO RESEARCH AND APPLY FOR ANY ADDITIONAL PERMITS THAT MAY APPLY TO THEIR SPECIFIC OPERATIONS.
