THERE ARE TWO MAIN TYPES OF COLLECTION AGENCIES: FIRST-PARTY AND THIRD-PARTY. FIRST-PARTY AGENCIES ARE OFTEN IN-HOUSE COLLECTIONS DEPARTMENTS THAT WORK DIRECTLY FOR A BUSINESS, WHILE THIRD-PARTY AGENCIES OPERATE INDEPENDENTLY AND ARE CONTRACTED TO RECOVER DEBTS FOR MULTIPLE CLIENTS. SMALL BUSINESSES OFTEN BENEFIT FROM THIRD-PARTY AGENCIES DUE TO THEIR EXPERTISE, RESOURCES, AND EXPERIENCE IN MANAGING COLLECTIONS.
