- **CAPACITY:** PARTIES MUST HAVE THE LEGAL ABILITY TO ENTER INTO A CONTRACT.
- **LEGALITY:** THE CONTRACT'S PURPOSE MUST BE LEGAL AND NOT AGAINST PUBLIC POLICY.

UNDERSTANDING THESE COMPONENTS CAN HELP YOU RECOGNIZE THE IMPORTANCE OF HAVING A BUSINESS CONTRACT LAWYER REVIEW YOUR AGREEMENTS TO ENSURE THEY ARE ENFORCEABLE AND PROTECT YOUR INTERESTS.

Q: CAN I HANDLE CONTRACTS WITHOUT A LAWYER?

A: WHILE IT IS POSSIBLE TO HANDLE CONTRACTS WITHOUT A LAWYER, IT IS NOT ADVISABLE. THE LEGAL LANGUAGE CAN BE COMPLEX, AND WITHOUT PROFESSIONAL GUIDANCE, YOU MAY OVERLOOK CRITICAL DETAILS THAT COULD LEAD TO DISPUTES OR LEGAL ISSUES.

Q: WHAT HAPPENS IF I BREACH A CONTRACT?

A: BREACHING A CONTRACT CAN RESULT IN LEGAL CONSEQUENCES, INCLUDING FINANCIAL PENALTIES OR BEING SUED FOR DAMAGES. IT IS ESSENTIAL TO UNDERSTAND YOUR OBLIGATIONS UNDER THE CONTRACT TO AVOID BREACHES.
