UNDERSTANDING BUSINESS LICENSES

A BUSINESS LICENSE IS A PERMIT ISSUED BY THE GOVERNMENT THAT ALLOWS INDIVIDUALS OR COMPANIES TO CONDUCT BUSINESS WITHIN A SPECIFIC JURISDICTION. - **HEALTH PERMITS:** NECESSARY FOR BUSINESSES THAT DEAL WITH FOOD SERVICES OR HEALTH-RELATED SERVICES.
- **BUILDING PERMITS:** REQUIRED FOR BUSINESSES THAT INTEND TO CONSTRUCT OR SIGNIFICANTLY MODIFY THEIR PHYSICAL SPACES.
- **SIGNAGE PERMITS:** NEEDED FOR BUSINESSES PLANNING TO INSTALL EXTERNAL SIGNAGE.

THE APPLICATION PROCESS

APPLYING FOR A BUSINESS LICENSE IN WEST COVINA INVOLVES SEVERAL STEPS THAT MUST BE FOLLOWED METICULOUSLY TO ENSURE A SMOOTH PROCESS. UNDERSTANDING THESE STEPS CAN HELP EXPEDITE YOUR APPLICATION.
