3. INSERTS

WHEN ADDRESSING FINANCIAL MATTERS, INCLUDING A SUMMARY REPORT AS AN ENCLOSURE CAN PROVIDE CLARITY. A LETTER MIGHT MENTION, “ATTACHED YOU WILL FIND THE FINANCIAL REPORT FOR Q3, WHICH OUTLINES OUR PERFORMANCE METRICS.” THIS ENSURES THE RECIPIENT HAS ALL THE NECESSARY DATA FOR INFORMED DISCUSSIONS.

4. FOLLOW-UP LETTERS

AFTER AN INITIAL PROPOSAL, A FOLLOW-UP LETTER CAN INCLUDE ADDITIONAL MATERIALS SUCH AS TIMELINES OR CASE STUDIES. THE LETTER COULD STATE, “ENCLOSED ARE CASE STUDIES FROM PREVIOUS PROJECTS THAT DEMONSTRATE OUR CAPABILITIES.” THIS REINFORCES THE PRIMARY MESSAGE AND PROVIDES SUPPORTING EVIDENCE.
