VARIOUS TYPES OF BUSINESSES, FROM RETAIL SHOPS TO SERVICE PROVIDERS, REQUIRE A BUSINESS LICENSE TO OPERATE LEGALLY.

BUSINESS LICENSES SERVE MULTIPLE PURPOSES, INCLUDING TAXATION, REGULATION, AND ENSURING PUBLIC HEALTH AND SAFETY.

GENERAL BUSINESS LICENSE

THE GENERAL BUSINESS LICENSE IS REQUIRED FOR MOST BUSINESSES OPERATING WITHIN HUMBOLDT COUNTY. THIS LICENSE

SPECIAL PERMITS AND LICENSES
