- RAW MATERIALS
- MANUFACTURING LABOR
- SHIPPING COSTS
- INVENTORY STORAGE

PROFESSIONAL SERVICES

MANY SMALL BUSINESSES RELY ON PROFESSIONAL SERVICES FOR VARIOUS ASPECTS OF OPERATION. THIS CATEGORY CAN INCLUDE EXPENSES FOR:

- LEGAL CONSULTATIONS
- ACCOUNTING AND BOOKKEEPING SERVICES
- CONSULTING FEES
- IT SUPPORT AND SERVICES

TRAVEL AND MEALS
