At the National Mall—America's front lawn—citizens exercise their rights of assembly and free speech, as well as play football, eat lunch, and socialize. From historic Lincoln Square, Dupont Circle, and Judiciary Square to the newly developed Freedom Plaza, Pershing Park, and Market Square, Bednar's thoughtful study provides a fresh perspective on the role of public space in the expression of democratic ideals.

As a result, America is witnessing the emergence of what Hyra calls "cappuccino cities." A cappuccino has essentially the same ingredients as a cup of coffee with milk, but is considered upscale, and is double the price. In Hyra's cappuccino city, the black inner-city neighborhood undergoes enormous transformations and becomes racially "lighter" and more expensive by the year.
