GENERAL BUSINESS LICENSE

- **FOOD SERVICE LICENSE:** REQUIRED FOR RESTAURANTS, CAFES, AND FOOD TRUCKS.
- **HEALTH AND BEAUTY LICENSE:** REQUIRED FOR SALONS, SPAS, AND WELLNESS CENTERS.
- **CONTRACTOR'S LICENSE:** REQUIRED FOR CONSTRUCTION-RELATED BUSINESSES.
- **LIQUOR LICENSE:** REQUIRED FOR ESTABLISHMENTS SERVING ALCOHOL.

EACH OF THESE SPECIALIZED LICENSES COMES WITH ITS OWN SET OF REGULATIONS AND REQUIREMENTS THAT MUST BE MET. THEREFORE, BUSINESSES SHOULD CAREFULLY IDENTIFY WHICH LICENSES THEY NEED BASED ON THEIR OPERATIONS.

THE APPLICATION PROCESS FOR A BUSINESS LICENSE

APPLYING FOR A HAMILTON COUNTY BUSINESS LICENSE REQUIRES FOLLOWING A SPECIFIC PROCESS DESIGNED TO ENSURE COMPLIANCE WITH LOCAL LAWS. UNDERSTANDING THIS PROCESS CAN HELP STREAMLINE YOUR APPLICATION AND AVOID DELAYS.

FEES ASSOCIATED WITH A BUSINESS LICENSE

Q: IS IT POSSIBLE TO TRANSFER MY BUSINESS LICENSE TO ANOTHER OWNER?

A: YES, BUT THE PROCESS MAY REQUIRE NOTIFYING THE HAMILTON COUNTY LICENSING AUTHORITY AND MEETING SPECIFIC REQUIREMENTS TO ENSURE THE NEW OWNER MEETS ALL LICENSING CRITERIA.
