UNDERSTANDING STARTUP COSTS

FIXED COSTS

FIXED COSTS ARE EXPENSES THAT DO NOT CHANGE REGARDLESS OF THE BUSINESS'S PERFORMANCE. THESE INCLUDE:

- **BUSINESS REGISTRATION FEES:** COSTS ASSOCIATED WITH LEGALLY REGISTERING YOUR BUSINESS NAME AND OBTAINING NECESSARY LICENSES AND PERMITS.
- **EQUIPMENT AND SUPPLIES:** INITIAL INVESTMENTS IN TOOLS, MACHINERY, OR INVENTORY NEEDED TO START OPERATIONS.
- **OFFICE OR RETAIL SPACE:** RENT OR LEASE PAYMENTS FOR PHYSICAL LOCATIONS, IF APPLICABLE.

VARIABLE COSTS

VARIABLE COSTS FLUCTUATE WITH THE LEVEL OF PRODUCTION OR SALES. THESE COSTS MAY INCLUDE:

- **MARKETING EXPENSES:** COSTS RELATED TO ADVERTISING, BRANDING, AND PROMOTIONAL CAMPAIGNS.
- **UTILITIES:** MONTHLY BILLS FOR ELECTRICITY, WATER, INTERNET, AND OTHER SERVICES.
- **PAYROLL:** WAGES AND BENEFITS FOR EMPLOYEES.

TYPES OF BUSINESSES AND THEIR COSTS

SERVICE-BASED BUSINESSES

SERVICE-BASED BUSINESSES OFTEN HAVE LOWER STARTUP COSTS COMPARED TO PRODUCT-BASED BUSINESSES. COMMON EXPENSES MIGHT INCLUDE:

- MARKETING AND PROMOTIONAL MATERIALS
- LICENSES OR CERTIFICATIONS SPECIFIC TO THE SERVICE
- EQUIPMENT, SUCH AS COMPUTERS OR SPECIALIZED TOOLS

PRODUCT-BASED BUSINESSES

PRODUCT-BASED BUSINESSES TYPICALLY REQUIRE MORE UPFRONT INVESTMENT DUE TO INVENTORY COSTS. KEY EXPENSES INCLUDE:

- INVENTORY PURCHASE
- STORAGE SPACE OR WAREHOUSE RENTAL
- MANUFACTURING EQUIPMENT, IF APPLICABLE

ONLINE BUSINESSES

ONLINE BUSINESSES MAY INVOLVE UNIQUE COSTS SUCH AS:

- WEBSITE DEVELOPMENT AND HOSTING FEES
- DIGITAL MARKETING CAMPAIGNS
- ECOMMERCE PLATFORM FEES

ONGOING EXPENSES

OPERATIONAL COSTS

ATTRACTING INVESTORS CAN BE ANOTHER METHOD TO FUND A BUSINESS. THIS OPTION INVOLVES SHARING OWNERSHIP BUT CAN PROVIDE SUBSTANTIAL CAPITAL FOR EXPANSION.
