LEGAL REQUIREMENTS FOR BUSINESS NAMES IN GEORGIA

BUSINESS ENTITY TYPES AND NAMING RULES

IN GEORGIA, THE RULES GOVERNING BUSINESS NAMES VARY DEPENDING ON THE TYPE OF BUSINESS ENTITY YOU CHOOSE. COMMON TYPES INCLUDE SOLE PROPRIETORSHIPS, PARTNERSHIPS, LIMITED LIABILITY COMPANIES (LLCS), AND CORPORATIONS. EACH ENTITY HAS SPECIFIC NAMING REQUIREMENTS THAT MUST BE ADHERED TO.

- **SOLE PROPRIETORSHIPS:** THESE BUSINESSES MAY OPERATE UNDER THE OWNER'S LEGAL NAME OR A FICTITIOUS NAME REGISTERED WITH THE COUNTY.
- **PARTNERSHIPS:** SIMILAR TO SOLE PROPRIETORSHIPS, PARTNERSHIPS CAN USE THE NAMES OF THE PARTNERS OR A

REGISTERED TRADE NAME.

- **LLCs:** THE NAME MUST INCLUDE “LIMITED LIABILITY COMPANY” OR AN ABBREVIATION, SUCH AS “LLC” OR “L.L.C.”
- **CORPORATIONS:** THE NAME MUST INCLUDE “CORPORATION,” “INCORPORATED,” OR ABBREVIATIONS LIKE “INC.” OR “CORP.”

MOREOVER, ALL BUSINESS NAMES MUST BE DISTINGUISHABLE FROM EXISTING REGISTERED NAMES IN GEORGIA. THIS MEANS YOUR CHOSEN NAME CANNOT BE TOO SIMILAR TO ANOTHER BUSINESS NAME IN ORDER TO AVOID CONFUSION AMONG CONSUMERS.

TRADEMARK CONSIDERATIONS

ASIDE FROM STATE REQUIREMENTS, IT IS CRUCIAL TO CONSIDER FEDERAL TRADEMARK LAWS. A NAME THAT IS ALREADY TRADEMARKED AT THE FEDERAL LEVEL CANNOT BE USED FOR YOUR BUSINESS, EVEN IF IT IS AVAILABLE IN GEORGIA. CONDUCTING A TRADEMARK SEARCH THROUGH THE UNITED STATES PATENT AND TRADEMARK OFFICE (USPTO) CAN HELP ENSURE YOUR DESIRED NAME IS NOT INFRINGING ON EXISTING TRADEMARKS.

STEPS TO CONDUCT A NAME SEARCH FOR YOUR BUSINESS

1. IDENTIFY YOUR DESIRED BUSINESS NAME

THE FIRST STEP IS TO BRAINSTORM POTENTIAL NAMES FOR YOUR BUSINESS. CONSIDER NAMES THAT REFLECT YOUR BRAND’S IDENTITY AND THE PRODUCTS OR SERVICES YOU OFFER. AIM FOR NAMES THAT ARE MEMORABLE, EASY TO SPELL, AND RELEVANT TO YOUR TARGET AUDIENCE.

2. CHECK AVAILABILITY ON THE GEORGIA SECRETARY OF STATE’S WEBSITE

THE GEORGIA SECRETARY OF STATE’S WEBSITE PROVIDES AN ONLINE DATABASE FOR USERS TO SEARCH FOR EXISTING BUSINESS NAMES. FOLLOW THESE STEPS TO CHECK NAME AVAILABILITY:

- VISIT THE GEORGIA SECRETARY OF STATE’S BUSINESS SEARCH PORTAL.
- ENTER YOUR DESIRED BUSINESS NAME IN THE SEARCH BAR.
- REVIEW THE RESULTS TO SEE IF THE NAME IS ALREADY IN USE.

3. CONDUCT A TRADEMARK SEARCH

AFTER CONFIRMING THE NAME’S AVAILABILITY AT THE STATE LEVEL, THE NEXT STEP IS TO PERFORM A TRADEMARK SEARCH. USE THE USPTO’S TRADEMARK ELECTRONIC SEARCH SYSTEM (TESS) TO CHECK IF YOUR DESIRED NAME OR A SIMILAR ONE IS FEDERALLY TRADEMARKED.

4. CONSIDER DOMAIN NAME AVAILABILITY

IN TODAY'S DIGITAL AGE, HAVING AN ONLINE PRESENCE IS ESSENTIAL. CHECK FOR THE AVAILABILITY OF THE DOMAIN NAME THAT MATCHES YOUR BUSINESS NAME. THIS CAN ENHANCE YOUR BRANDING EFFORTS AND MAKE IT EASIER FOR CUSTOMERS TO FIND YOU ONLINE.

RESOURCES FOR NAME SEARCHES IN GEORGIA

ONLINE DATABASES

THE GEORGIA SECRETARY OF STATE'S WEBSITE IS THE PRIMARY RESOURCE FOR CONDUCTING A NAME SEARCH. IT IS USER-FRIENDLY AND PROVIDES UP-TO-DATE INFORMATION ON REGISTERED BUSINESSES. ADDITIONALLY, CONSIDER USING THE FOLLOWING RESOURCES:

- **USPTO TRADEMARK DATABASE:** FOR CHECKING FEDERAL TRADEMARK REGISTRATIONS.
- **LOCAL COUNTY CLERK'S OFFICE:** TO REGISTER A FICTITIOUS NAME OR DBA (DOING BUSINESS AS) FOR SOLE PROPRIETORSHIPS OR PARTNERSHIPS.
- **ONLINE DOMAIN REGISTRARS:** TO VERIFY THE AVAILABILITY OF WEBSITE DOMAINS.
