UNDERSTANDING NON-EMERGENCY MEDICAL TRANSPORTATION

NON-EMERGENCY MEDICAL TRANSPORTATION REFERS TO TRANSPORTATION SERVICES THAT ASSIST PATIENTS IN REACHING THEIR MEDICAL APPOINTMENTS WHEN THEY DO NOT REQUIRE URGENT CARE.
