Staff are fooled by these even when they know they could be tested. These represent opportunities to embed learning points and encourage staff to take their time, trust their instincts and validate. Information security awareness should help establish correct security procedures and security principles in the minds of all employees. Increased awareness minimizes user-related security threats and maximizes the efficiency of security techniques.
