- **CORPORATION:** CORPORATIONS ARE MORE COMPLEX ENTITIES THAT PROVIDE THE HIGHEST LEVEL OF PERSONAL LIABILITY PROTECTION. THEY CAN BE EITHER C CORPORATIONS OR S CORPORATIONS, DEPENDING ON TAX STRUCTURE PREFERENCES.

- **BUSINESS LICENSES AND PERMITS:** DEPENDING ON YOUR INDUSTRY, YOU MAY NEED SPECIFIC LICENSES OR PERMITS TO OPERATE LEGALLY.
