ELIGIBILITY REQUIREMENTS FOR REGISTERING A BUSINESS NAME IN OHIO

BEFORE YOU BEGIN THE REGISTRATION PROCESS, IT'S IMPORTANT TO UNDERSTAND THE ELIGIBILITY REQUIREMENTS FOR REGISTERING A BUSINESS NAME IN OHIO. GENERALLY, ANY INDIVIDUAL OR ENTITY PLANNING TO CONDUCT BUSINESS UNDER A NAME OTHER THAN THEIR LEGAL NAME MUST REGISTER THAT NAME. TYPES OF BUSINESS NAMES

IN OHIO, THERE ARE VARIOUS TYPES OF BUSINESS NAMES YOU CAN REGISTER:

- **TRADE NAME:** ALSO KNOWN AS A "DOING BUSINESS AS" (DBA) NAME, THIS IS THE NAME UNDER WHICH YOUR BUSINESS OPERATES THAT IS DIFFERENT FROM YOUR PERSONAL NAME OR THE LEGAL NAME OF YOUR BUSINESS ENTITY.
- **ENTITY NAME:** THIS IS THE OFFICIAL NAME OF YOUR CORPORATION OR LLC AS REGISTERED WITH THE OHIO SECRETARY OF STATE.
- **ASSUMED NAME:** SIMILAR TO A TRADE NAME, THIS IS ANOTHER NAME UNDER WHICH A BUSINESS OPERATES THAT IS NOT ITS LEGAL NAME.

GENERAL REQUIREMENTS

TO REGISTER YOUR BUSINESS NAME IN OHIO, YOU MUST FULFILL THE FOLLOWING CRITERIA:

- YOU MUST CHOOSE A NAME THAT IS NOT ALREADY IN USE BY ANOTHER BUSINESS ENTITY IN OHIO.
- THE NAME MUST COMPLY WITH OHIO NAMING REGULATIONS, WHICH MAY PROHIBIT CERTAIN WORDS OR PHRASES.
- FOR LLCs AND CORPORATIONS, THE NAME MUST INCLUDE DESIGNATORS SUCH AS "LLC," "INC.," OR "CORP." AS APPLICABLE.

STEP-BY-STEP GUIDE TO REGISTERING YOUR BUSINESS NAME ONLINE

Q: WHAT HAPPENS IF I DON'T REGISTER MY BUSINESS NAME?

A: FAILING TO REGISTER YOUR BUSINESS NAME CAN LEAD TO LEGAL ISSUES, LOSS OF BRAND IDENTITY, AND POTENTIAL PENALTIES FOR OPERATING UNDER AN UNREGISTERED NAME.
