UNDERSTANDING BUSINESS NAME REGISTRATION

TYPES OF BUSINESS NAMES IN TEXAS

IN TEXAS, THERE ARE DIFFERENT TYPES OF BUSINESS NAMES THAT CAN BE REGISTERED, AND UNDERSTANDING EACH TYPE IS VITAL FOR COMPLIANCE AND BRANDING PURPOSES. THE PRIMARY CATEGORIES INCLUDE:

1. LEGAL BUSINESS NAME

A LEGAL BUSINESS NAME IS THE OFFICIAL NAME UNDER WHICH A BUSINESS OPERATES. THIS NAME IS USED IN LEGAL DOCUMENTS, CONTRACTS, AND TAX FILINGS. FOR CORPORATIONS AND LLCs, THIS NAME MUST BE UNIQUE AND DISTINGUISHABLE FROM OTHER REGISTERED ENTITIES IN TEXAS.

2. ASSUMED NAME (DBA)

AN ASSUMED NAME, COMMONLY REFERRED TO AS A "DOING BUSINESS AS" (DBA), IS A NAME THAT A BUSINESS USES THAT IS DIFFERENT FROM ITS LEGAL NAME. THIS IS PARTICULARLY COMMON FOR SOLE PROPRIETORS WHO WANT TO OPERATE UNDER A MORE RECOGNIZABLE BUSINESS NAME. REGISTERING A DBA IS REQUIRED IF YOU WANT TO USE A NAME THAT DOES NOT INCLUDE THE OWNER'S LAST NAME OR IS NOT THE LEGAL NAME OF THE ENTITY.

3. TRADEMARKED NAME

A TRADEMARKED NAME IS A NAME THAT HAS BEEN LEGALLY REGISTERED WITH THE UNITED STATES PATENT AND TRADEMARK OFFICE (USPTO) OR THE TEXAS SECRETARY OF STATE TO PROTECT THE BRAND. THIS REGISTRATION PROVIDES LEGAL RIGHTS AND PREVENTS OTHERS FROM USING A SIMILAR NAME IN THE SAME INDUSTRY.

STEPS TO REGISTER A BUSINESS NAME

THE PROCESS TO REGISTER A BUSINESS NAME IN TEXAS INVOLVES SEVERAL KEY STEPS. FOLLOWING THESE STEPS CAREFULLY WILL HELP ENSURE A SMOOTH REGISTRATION PROCESS.

1. **CHOOSE YOUR BUSINESS NAME:** BEFORE REGISTERING, BRAINSTORM AND SELECT A NAME THAT RESONATES WITH YOUR TARGET AUDIENCE AND REPRESENTS YOUR BRAND. ENSURE THE NAME ALIGNS WITH TEXAS NAMING RULES, AVOIDING PROHIBITED WORDS AND PHRASES.

3. **FILE FOR REGISTRATION:** DEPENDING ON THE TYPE OF NAME YOU ARE REGISTERING (LEGAL NAME OR DBA), COMPLETE THE APPROPRIATE REGISTRATION FORMS. FOR A DBA, FILL OUT THE ASSUMED NAME CERTIFICATE AND SUBMIT IT TO THE COUNTY CLERK'S OFFICE WHERE YOUR BUSINESS IS LOCATED.
4. **PAY THE REQUIRED FEES:** REGISTRATION FEES VARY BASED ON THE TYPE OF BUSINESS NAME. ENSURE YOU CHECK THE CURRENT FEE STRUCTURE ON THE TEXAS SECRETARY OF STATE'S WEBSITE.
5. **RECEIVE CONFIRMATION:** AFTER PROCESSING YOUR APPLICATION, YOU WILL RECEIVE A CONFIRMATION OF YOUR BUSINESS NAME REGISTRATION. KEEP THIS DOCUMENT FOR YOUR RECORDS.

- **MARKETING ADVANTAGES:** A UNIQUE AND CATCHY BUSINESS NAME CAN SIGNIFICANTLY ENHANCE YOUR MARKETING EFFORTS, HELPING YOU STAND OUT IN A COMPETITIVE MARKETPLACE.

COMMON MISTAKES TO AVOID

WHILE REGISTERING A BUSINESS NAME IN TEXAS IS A RELATIVELY STRAIGHTFORWARD PROCESS, THERE ARE SEVERAL COMMON MISTAKES THAT INDIVIDUALS SHOULD AVOID:

2. IGNORING STATE NAMING RULES

TEXAS HAS SPECIFIC RULES REGARDING WHAT WORDS AND PHRASES CAN BE INCLUDED IN A BUSINESS NAME. IGNORING THESE RESTRICTIONS COULD RESULT IN REJECTION OF YOUR APPLICATION.

3. FAILING TO REGISTER A DBA WHEN REQUIRED

IF YOU INTEND TO OPERATE UNDER A NAME THAT IS DIFFERENT FROM YOUR LEGAL BUSINESS NAME, ENSURE YOU REGISTER A DBA TO COMPLY WITH STATE LAW.

4. NOT KEEPING RECORDS

ALWAYS KEEP A COPY OF YOUR REGISTRATION DOCUMENTS AND CONFIRMATION FOR YOUR RECORDS. THIS CAN BE ESSENTIAL FOR LEGAL AND FINANCIAL MATTERS IN THE FUTURE.

Q: WHAT IS THE COST TO REGISTER A BUSINESS NAME IN TEXAS?

A: THE COST VARIES DEPENDING ON THE TYPE OF REGISTRATION. FOR DBAs, THE FEE TYPICALLY RANGES FROM \$10 TO \$25, DEPENDING ON THE COUNTY. LEGAL BUSINESS NAME REGISTRATION FEES MAY VARY FOR LLCs AND CORPORATIONS.

Q: HOW LONG DOES IT TAKE TO REGISTER A BUSINESS NAME IN TEXAS?

A: THE REGISTRATION PROCESS CAN TAKE ANYWHERE FROM A FEW DAYS TO SEVERAL WEEKS, DEPENDING ON THE METHOD OF SUBMISSION AND THE WORKLOAD OF THE TEXAS SECRETARY OF STATE'S OFFICE.

Q: DO I NEED TO REGISTER A DBA IF I AM A SOLE PROPRIETOR?

A: YES, IF YOU PLAN TO OPERATE UNDER A NAME THAT DOES NOT INCLUDE YOUR PERSONAL NAME, YOU MUST REGISTER A DBA.

Q: CAN I RESERVE A BUSINESS NAME IN TEXAS BEFORE REGISTRATION?

A: YES, TEXAS ALLOWS YOU TO RESERVE A BUSINESS NAME FOR 120 DAYS BY FILING AN APPLICATION AND PAYING THE REQUIRED FEE.

Q: WHAT HAPPENS IF MY BUSINESS NAME IS REJECTED?

A: IF YOUR BUSINESS NAME IS REJECTED, YOU WILL RECEIVE A NOTIFICATION EXPLAINING THE REASON. YOU CAN THEN MODIFY YOUR NAME AND REAPPLY.

Q: ARE THERE ANY PROHIBITED WORDS WHEN REGISTERING A BUSINESS NAME IN TEXAS?

A: YES, CERTAIN WORDS ARE PROHIBITED, SUCH AS "BANK," "INSURANCE," "TRUST," AND OTHERS UNLESS YOU HAVE THE NECESSARY LICENSES TO USE THEM.

Q: CAN I CHANGE MY BUSINESS NAME AFTER REGISTRATION?

A: YES, YOU CAN CHANGE YOUR BUSINESS NAME AFTER REGISTRATION BY FOLLOWING THE PROPER PROCEDURES FOR AMENDING YOUR REGISTRATION.

Q: IS IT NECESSARY TO TRADEMARK MY BUSINESS NAME IN ADDITION TO REGISTERING IT?

A: WHILE REGISTRATION PROVIDES SOME LEVEL OF PROTECTION, TRADEMARKING YOUR BUSINESS NAME OFFERS STRONGER LEGAL PROTECTION AGAINST INFRINGEMENT.

Q: HOW OFTEN DO I NEED TO RENEW MY BUSINESS NAME REGISTRATION IN TEXAS?

A: BUSINESS NAME REGISTRATIONS DO NOT EXPIRE, BUT YOU SHOULD MAINTAIN ACCURATE RECORDS AND UPDATE ANY CHANGES TO YOUR BUSINESS INFORMATION AS NECESSARY.

Q: WHAT IF SOMEONE ELSE IS USING MY REGISTERED BUSINESS NAME?

A: IF SOMEONE ELSE IS USING YOUR REGISTERED BUSINESS NAME, YOU MAY HAVE LEGAL GROUNDS TO PURSUE A TRADEMARK INFRINGEMENT CLAIM. IT IS ADVISABLE TO CONSULT WITH A LEGAL PROFESSIONAL FOR GUIDANCE.
