- **EXCLUSIVE PROVIDER ORGANIZATION (EPO):** EPO PLANS ARE SIMILAR TO PPOs BUT DO NOT COVER OUT-OF-NETWORK CARE EXCEPT IN EMERGENCIES. THEY TEND TO HAVE LOWER PREMIUMS.
- **HIGH DEDUCTIBLE HEALTH PLANS (HDHP):** THESE PLANS HAVE HIGHER DEDUCTIBLES AND LOWER PREMIUMS, MAKING THEM A MORE AFFORDABLE OPTION FOR SOME SMALL BUSINESSES. THEY ARE OFTEN PAIRED WITH HEALTH SAVINGS ACCOUNTS (HSAs).

DENTAL INSURANCE PLANS

DENTAL INSURANCE OPTIONS INCLUDE:

- **PREVENTIVE PLANS:** THESE FOCUS ON PREVENTIVE CARE, COVERING ROUTINE CHECK-UPS AND CLEANINGS.
- **BASIC PLANS:** IN ADDITION TO PREVENTIVE CARE, THEY COVER BASIC PROCEDURES SUCH AS FILLINGS AND EXTRACTIONS.
