A: IT IS ADVISABLE TO REVIEW YOUR PRODUCT LIABILITY INSURANCE POLICY ANNUALLY OR WHENEVER SIGNIFICANT CHANGES OCCUR IN YOUR BUSINESS, SUCH AS THE INTRODUCTION OF NEW PRODUCTS OR CHANGES IN BUSINESS OPERATIONS.
