A new dimension in canine utilization was realized when marijuana detector dog teams were trained and deployed to assist military police in suppressing illicit drug traffic. Sentry and marijuana detector dog teams were then deployed worldwide in support of military police. An important outgrowth of the conflict was the development of canine research and development efforts.
