Proof of the Fundamental Theorem of Calculus

$$\int_a^b f(x) \, dx = f(c)(b - a)$$

Since F is continuous, we can state that:

$$F(b) - F(a) = f(c)(b - a)$$

This completes the proof of Part 1.

Proof of Part 2

To prove Part 2, we again consider a function f that is integrable on $[a, b]$. We define the function $F(x) = \int_a^x f(t) \, dt$.

Since f is integrable, F is continuous on $[a, b]$. To show that F is differentiable, we again use the definition of the derivative:

$$F'(x) = \lim_{h \rightarrow 0} \frac{F(x+h) - F(x)}{h}$$

Applying the definition of F :

$$F'(x) = f(x)$$
