$$f(0.25) = (0.25)^2 = 0.0625$$

• 
$$f(0.75) = (0.75)^2 = 0.5625$$

- $f(1.25) = (1.25)^2 = 1.5625$
- $f(1.75) = (1.75)^2 = 3.0625$

Finally, we can apply the midpoint rule formula:

$$M_4 = \Delta x \sum_{i=1}^{n} f(x_i) = 0.5 \cdot (0.0625 + 0.5625 + 1.5625 + 3.0625) = 0.5 \cdot (0.0625 + 0.0625 + 1.5625 + 1.$$
