- If  $p \le 1$ : The integral diverges as x approaches infinity.

This relationship between the integral and the series solidifies the reasoning behind the ptest, providing a robust mathematical basis for its use in calculus.

Lastly, consider the series  $\Sigma$  (1/n^(1/2)). Here, p = 1/2:

•  $p = 1/2 \le 1$ , therefore the series diverges.

This series, like the harmonic series, does not approach a finite limit as n increases.

### Limitations of the p-test

While the p-test is a powerful tool, it does have limitations. One key limitation is that it only applies to positive term series of the form  $\Sigma$  (1/n^p). If a series does not fit this form, the p-test cannot determine its convergence or divergence.
