UNDERSTANDING THE CER UNEMPLOYMENT FORM

IN-PERSON COLLECTION

APPLICANTS MAY VISIT LOCAL EMPLOYMENT OFFICES OR CER CENTERS TO COLLECT A PHYSICAL COPY OF THE FORM. STAFF AT THESE CENTERS CAN ALSO OFFER GUIDANCE ON THE COMPLETION PROCESS.

MAIL REQUEST

SOME AGENCIES ALLOW APPLICANTS TO REQUEST THE FORM BY MAIL, WHICH IS THEN SENT DIRECTLY TO THEIR HOME ADDRESS. THIS OPTION IS USEFUL FOR INDIVIDUALS WITHOUT INTERNET ACCESS OR THOSE PREFERRING PAPER CORRESPONDENCE.

STEP-BY-STEP GUIDE TO COMPLETING THE CER UNEMPLOYMENT FORM

MISSING SIGNATURES OR DATES

UNSIGNED FORMS OR MISSING DATES INVALIDATE APPLICATIONS. DOUBLE-CHECK THAT THE FORM IS PROPERLY SIGNED AND DATED BEFORE SUBMISSION.

MAIL SUBMISSION

APPLICANTS MAY SEND THE COMPLETED FORM AND DOCUMENTS VIA CERTIFIED MAIL TO ENSURE DELIVERY CONFIRMATION. RETAINING COPIES OF ALL DOCUMENTS IS ADVISABLE.

IN-PERSON SUBMISSION
