# FINANCING COMMERCIAL REAL ESTATE OPPORTUNITIES

## COMMERCIAL MORTGAGE-BACKED SECURITIES (CMBS)

CMBS LOANS ARE A FORM OF SECURITIZED DEBT THAT POOLS COMMERCIAL MORTGAGES INTO BONDS SOLD TO INVESTORS. THESE LOANS TYPICALLY OFFER FIXED INTEREST RATES AND CAN BE USED FOR LARGER TRANSACTIONS, ALTHOUGH THEY MAY HAVE STRICTER UNDERWRITING STANDARDS.

## ALTERNATIVE FINANCING OPTIONS

PRIVATE EQUITY, CROWDFUNDING PLATFORMS, AND HARD MONEY LENDERS PROVIDE ALTERNATIVE FINANCING SOURCES. THESE OPTIONS MAY OFFER GREATER FLEXIBILITY AND FASTER APPROVAL BUT OFTEN COME WITH HIGHER COSTS AND RISK LEVELS.
