MITIGATION INVOLVES STRATEGIES TO REDUCE THE IMPACT OF DISASTERS BEFORE THEY OCCUR, SUCH AS HAZARD ASSESSMENTS AND BUILDING CODES. PREPAREDNESS FOCUSES ON PLANNING, TRAINING, AND EXERCISES TO ENSURE READINESS FOR EMERGENCIES.

YES, GENERALLY YOU CAN RETAKE FEMA TRAINING TESTS IF YOU DO NOT PASS ON YOUR FIRST ATTEMPT. FEMA ENCOURAGES LEARNING AND MASTERY OF EMERGENCY MANAGEMENT CONCEPTS, SO MULTIPLE ATTEMPTS ARE ALLOWED TO ENSURE COMPETENCY.

HOW CAN I PREPARE EFFECTIVELY FOR FEMA TRAINING EXAMS?
