ELIGIBILITY REQUIREMENTS FOR THE ILLINOIS DMV PERMIT TEST

PARENTAL CONSENT

FOR APPLICANTS UNDER 18, PARENTAL OR GUARDIAN CONSENT IS MANDATORY. THIS CONSENT VERIFIES THAT THE MINOR HAS PERMISSION TO APPLY FOR AND HOLD A LEARNER'S PERMIT, ACKNOWLEDGING THE RESPONSIBILITIES INVOLVED.

APPLICATION PROCESS FOR THE ILLINOIS DRIVING PERMIT
