VLAD THE IMPALER, ALSO KNOWN AS DRACULA, IS BELIEVED TO HAVE DIED IN BATTLE AROUND 1476. HIS DEATH IS CONSIDERED BRUTAL DUE TO HIS NOTORIOUS REPUTATION FOR IMPALING HIS ENEMIES ALIVE, REFLECTING THE VIOLENT ERA HE LIVED IN, ALTHOUGH THE EXACT DETAILS OF HIS DEATH REMAIN UNCERTAIN.

WHAT WAS THE METHOD OF EXECUTION FOR ANNE BOLEYN, AND WHY IS IT CONSIDERED PARTICULARLY BRUTAL?

ANNE BOLEYN, THE SECOND WIFE OF KING HENRY VIII, WAS EXECUTED BY BEHEADING IN 1536.
