MICHAEL SWANGO CRIMES REPRESENT ONE OF THE MOST CHILLING AND NOTORIOUS CASES IN MODERN MEDICAL CRIMINAL HISTORY. SWANGO, A LICENSED PHYSICIAN, ENGAGED IN A SERIES OF DELIBERATE AND FATAL POISONINGS THAT SPANNED SEVERAL YEARS AND MULTIPLE HEALTHCARE INSTITUTIONS. EARLY LIFE AND MEDICAL CAREER

MEDICAL TRAINING AND EARLY WARNING SIGNS

DURING HIS TIME IN MEDICAL SCHOOL AND RESIDENCY PROGRAMS, SWANGO EXHIBITED DISTURBING BEHAVIOR THAT RAISED CONCERNS AMONG PEERS AND SUPERVISORS. THERE WERE REPORTS OF UNEXPLAINED PATIENT DEATHS AND SUSPICIOUS INCIDENTS THAT WERE INITIALLY ATTRIBUTED TO NATURAL CAUSES OR MEDICAL COMPLICATIONS. THESE EARLY WARNING SIGNS WERE OFTEN OVERLOOKED OR INADEQUATELY INVESTIGATED, ALLOWING HIM TO CONTINUE PRACTICING MEDICINE. HIS ABILITY TO MAINTAIN A PROFESSIONAL FACADE HELPED HIM AVOID SCRUTINY.

EMPLOYMENT AT MULTIPLE MEDICAL INSTITUTIONS

SWANGO WORKED AT SEVERAL HOSPITALS AND CLINICS, OFTEN MOVING BETWEEN INSTITUTIONS. THIS PATTERN OF FREQUENT JOB CHANGES MADE IT DIFFICULT FOR AUTHORITIES TO CONNECT THE DOTS REGARDING THE SUSPICIOUS DEATHS AND ILLNESSES OCCURRING UNDER HIS CARE. HIS EMPLOYMENT HISTORY INCLUDED POSITIONS AS A RESIDENT, INTERN, AND ATTENDING PHYSICIAN, PROVIDING HIM WITH SIGNIFICANT ACCESS TO PATIENTS AND CONTROLLED SUBSTANCES.
