COMMON DRUG CATEGORIES IN NP PRACTICE

ANTIBIOTICS

NPs NEED TO UNDERSTAND INDICATIONS, SIDE EFFECT PROFILES, AND MONITORING REQUIREMENTS FOR THESE MEDICATIONS. THIS KNOWLEDGE ENSURES SAFE MANAGEMENT OF PSYCHIATRIC CONDITIONS WHILE MINIMIZING RISKS SUCH AS METABOLIC SYNDROME OR EXTRAPYRAMIDAL SYMPTOMS.

PRESCRIBING CONSIDERATIONS AND SAFETY
