COMMON TERMINOLOGY AND COMMUNICATIONS

CLEAR COMMUNICATION IS ESSENTIAL IN ICS. THE SYSTEM USES STANDARDIZED TERMINOLOGY TO AVOID MISUNDERSTANDINGS AND ENSURE INTEROPERABILITY ACROSS AGENCIES.
