ORIGINS AND EARLY CASES OF SERIAL KILLERS

TED BUNDY

TED BUNDY, ACTIVE IN THE 1970S, IS A KEY FIGURE IN MODERN SERIAL KILLER HISTORY. KNOWN FOR HIS CHARM AND INTELLIGENCE, BUNDY CONFESSED TO THE MURDERS OF MORE THAN 30 YOUNG WOMEN.
