In many Deaf communities, sign languages have developed naturally and independently, incorporating signs that can be neutral, positive, or offensive depending on their context and usage. Because sign languages are visual and gestural, the manifestation of racial slurs may differ from spoken words but can be equally impactful. Understanding the origins and meanings of these signs is crucial in addressing their use and consequences within social interactions.

NATURE OF OFFENSIVE SIGNS

COMMUNITY NORMS AND LANGUAGE EVOLUTION

AWARENESS HAS GROWN REGARDING THE HARMFUL NATURE OF THESE SIGNS, LEADING TO DISCUSSIONS ABOUT THEIR ELIMINATION OR REPLACEMENT.

BRITISH SIGN LANGUAGE (BSL)

BSL also contains signs that can be offensive or racially charged. The structure and style of these signs differ from ASL but serve similar linguistic and social functions. BSL users and educators actively work toward identifying and addressing offensive signs to foster a more inclusive environment.

OTHER SIGN LANGUAGES

Many other sign languages worldwide exhibit similar challenges with racial slurs embedded in their lexicons. The diversity of sign languages reflects varied cultural histories, and each community faces unique challenges in confronting hate speech and offensive language.
