The ted bundy victims were primarily young women, ranging in age from their late teens to mid-twenties. Bundy's criminal activities spanned several states, including Washington, Oregon, Utah, and Colorado, making his case complex and difficult to track. His victims were often abducted in public places, such as college campuses, parking lots, or while hitchhiking. Despite extensive investigations, the exact number of victims remains uncertain, with estimates ranging from 30 to over 40. Many of the victims were never found

I had a happy childhood until I received my first death sentence at the age of thirteen. Physicians weren't sure why I was always so exhausted and running a low-grade fever. The prognosis was grim after my left kidney started to fail. Then, a physician from Cuba saved my life with a surprise diagnosis—lupus—and treatment plan: chemotherapy. I endured chemotherapy again in my early thirties when I was diagnosed with stage 2 breast cancer. This is my story of surviving three death sentences and finding love and happiness along the way. I was saved by a bright light, and I hope my story is one for people who are experiencing their own dark times. I am a victim, but I am also a survivor, and I want to speak up for all the women and girls whom Bundy murdered. He has become a legend, and our voices have been muted or ignored. It's time we were heard.
