## ELIGIBILITY FOR TRAFFIC SCHOOL IN CALIFORNIA

DETERMINING ELIGIBILITY IS THE FIRST STEP FOR ANYONE CONSIDERING TRAFFIC SCHOOL IN CALIFORNIA. NOT ALL DRIVERS OR VIOLATIONS QUALIFY FOR TRAFFIC SCHOOL, SO UNDERSTANDING THE CRITERIA HELPS AVOID WASTED TIME AND RESOURCES. TYPICALLY, DRIVERS WITH A VALID CALIFORNIA DRIVER'S LICENSE WHO HAVE RECEIVED A TRAFFIC CITATION FOR A MOVING VIOLATION MAY BE ELIGIBLE, BUT THERE ARE RESTRICTIONS.

## WHO CAN ATTEND TRAFFIC SCHOOL?

CALIFORNIA ALLOWS DRIVERS TO ATTEND TRAFFIC SCHOOL UNDER SPECIFIC CONDITIONS:

- THE DRIVER MUST HAVE A VALID CALIFORNIA DRIVER'S LICENSE OR PERMIT.
- THE TRAFFIC VIOLATION MUST BE A MINOR MOVING VIOLATION (E.G., SPEEDING, FAILURE TO STOP).
- THE DRIVER CANNOT HAVE ATTENDED TRAFFIC SCHOOL FOR A PREVIOUS VIOLATION WITHIN THE LAST 18 MONTHS.
- THE VIOLATION MUST NOT BE RELATED TO SERIOUS OFFENSES SUCH AS DUI, RECKLESS DRIVING, OR DRIVING WITHOUT INSURANCE.

ADDITIONALLY, THE COURT OR THE DMV MUST ALLOW THE OPTION OF TRAFFIC SCHOOL FOR THE SPECIFIC CITATION.

## EXCEPTIONS AND LIMITATIONS

SOME VIOLATIONS ARE INELIGIBLE FOR TRAFFIC SCHOOL, INCLUDING BUT NOT LIMITED TO:

1. VIOLATIONS INVOLVING COMMERCIAL VEHICLES.
2. VIOLATIONS THAT CARRY MANDATORY COURT APPEARANCE ORDERS.
3. SERIOUS OFFENSES SUCH AS HIT-AND-RUN OR DRIVING UNDER THE INFLUENCE.
4. VIOLATIONS OCCURRING WITHIN 18 MONTHS OF A PREVIOUS TRAFFIC SCHOOL COMPLETION.

UNDERSTANDING THESE LIMITATIONS ENSURES THAT DRIVERS DO NOT ATTEMPT TRAFFIC SCHOOL WHEN IT IS NOT AN OPTION.

## ENROLLMENT AND COURSE STRUCTURE

ONCE ELIGIBILITY IS CONFIRMED, THE NEXT STEP IS ENROLLING IN AN APPROVED TRAFFIC SCHOOL COURSE. CALIFORNIA OFFERS VARIOUS OPTIONS, INCLUDING ONLINE AND IN-PERSON CLASSES, DESIGNED TO FIT DIFFERENT SCHEDULES AND PREFERENCES.

## HOW TO ENROLL IN TRAFFIC SCHOOL

ENROLLMENT CAN BE DONE THROUGH THE COURT, DMV, OR DIRECTLY VIA STATE-APPROVED TRAFFIC SCHOOL PROVIDERS. THE PROCESS IS STRAIGHTFORWARD:

## COURSE CONTENT AND DURATION

# BENEFITS OF COMPLETING TRAFFIC SCHOOL

## HIDING A TICKET FROM YOUR PUBLIC DRIVING RECORD

COMPLETING TRAFFIC SCHOOL ALLOWS DRIVERS TO MASK THE VIOLATION FROM THEIR PUBLIC DRIVING RECORD. THIS MEANS THE TICKET WILL NOT BE VISIBLE TO INSURANCE COMPANIES OR THE GENERAL PUBLIC, WHICH CAN PREVENT INCREASED INSURANCE PREMIUMS.

## POINT REDUCTION AND INSURANCE ADVANTAGES

IN CALIFORNIA, TRAFFIC VIOLATIONS ADD POINTS TO A DRIVER'S RECORD, WHICH CAN LEAD TO LICENSE SUSPENSION OR HIGHER INSURANCE RATES. SUCCESSFULLY COMPLETING TRAFFIC SCHOOL TYPICALLY RESULTS IN NO POINTS BEING ADDED FOR THE VIOLATION, HELPING MAINTAIN A CLEAN RECORD.

## ONE-TIME USE WITHIN 18 MONTHS

CALIFORNIA LAW ALLOWS TRAFFIC SCHOOL COMPLETION TO BE USED ONLY ONCE WITHIN AN 18-MONTH PERIOD. THIS PREVENTS DRIVERS FROM REPEATEDLY MASKING MINOR OFFENSES AND ENCOURAGES RESPONSIBLE DRIVING BEHAVIOR.

## REPORTING AND VERIFICATION

APPROVED TRAFFIC SCHOOLS ARE REQUIRED TO ELECTRONICALLY REPORT COURSE COMPLETION TO THE DMV OR THE COURT. DRIVERS SHOULD CONFIRM THAT THIS REPORTING HAS BEEN DONE TO ENSURE THEIR RECORDS ARE UPDATED ACCORDINGLY.

## IMPACT ON DRIVING RECORDS AND INSURANCE

THE EFFECTS OF ATTENDING TRAFFIC SCHOOL ON DRIVING RECORDS AND INSURANCE RATES ARE SIGNIFICANT CONSIDERATIONS

FOR MANY DRIVERS.

## DRIVING RECORD IMPLICATIONS

WHEN TRAFFIC SCHOOL IS COMPLETED SUCCESSFULLY, THE VIOLATION IS GENERALLY KEPT OFF THE PUBLIC DRIVING RECORD, MEANING IT WILL NOT AFFECT THE DRIVER'S POINT TOTAL. THIS HELPS MAINTAIN ELIGIBILITY FOR LOWER INSURANCE PREMIUMS AND REDUCES THE RISK OF LICENSE SUSPENSION DUE TO ACCUMULATED POINTS.

## INSURANCE CONSIDERATIONS

SINCE INSURANCE COMPANIES OFTEN REVIEW DRIVING RECORDS TO DETERMINE PREMIUMS, KEEPING A TICKET OFF THE PUBLIC RECORD BY ATTENDING TRAFFIC SCHOOL CAN PREVENT INCREASED RATES. HOWEVER, SOME INSURERS MIGHT STILL REQUEST DISCLOSURE OF TRAFFIC SCHOOL COMPLETIONS, SO DRIVERS SHOULD VERIFY WITH THEIR INSURANCE PROVIDER.

## COSTS AND PAYMENT METHODS

COSTS ASSOCIATED WITH TRAFFIC SCHOOL IN CALIFORNIA VARY DEPENDING ON THE PROVIDER AND COURSE FORMAT, BUT UNDERSTANDING TYPICAL EXPENSES AND PAYMENT OPTIONS IS IMPORTANT FOR PLANNING.

## TYPICAL FEES FOR TRAFFIC SCHOOL

- CREDIT AND DEBIT CARDS
- ONLINE PAYMENT PLATFORMS
- CHECKS OR MONEY ORDERS (FOR IN-PERSON OR MAIL-IN ENROLLMENTS)
- CASH PAYMENTS (TYPICALLY FOR IN-PERSON CLASSES)

DRIVERS SHOULD ENSURE PAYMENTS ARE MADE THROUGH SECURE AND APPROVED CHANNELS TO AVOID SCAMS OR DELAYS.
