WHAT IS A HAZMAT ENDORSEMENT?

A HAZMAT ENDORSEMENT IS A SPECIAL CERTIFICATION ADDED TO A COMMERCIAL DRIVER'S LICENSE (CDL) THAT AUTHORIZES THE DRIVER TO TRANSPORT HAZARDOUS MATERIALS LEGALLY. OBTAINING THIS ENDORSEMENT REQUIRES PASSING A KNOWLEDGE TEST THAT COVERS REGULATIONS FOR HANDLING DANGEROUS GOODS, SAFETY PROTOCOLS, AND SECURITY MEASURES. WALMART MANDATES THIS ENDORSEMENT FOR DRIVERS WHO TRANSPORT CHEMICALS, FLAMMABLE MATERIALS, OR OTHER REGULATED SUBSTANCES.

WHY WALMART REQUIRES HAZMAT TRAINING

FEDERAL REGULATORY FRAMEWORK

BACKGROUND CHECKS AND SECURITY THREAT ASSESSMENT

BEFORE RECEIVING A HAZMAT ENDORSEMENT, DRIVERS MUST UNDERGO A TRANSPORTATION SECURITY ADMINISTRATION (TSA) BACKGROUND CHECK AND FINGERPRINTING. THIS SECURITY THREAT ASSESSMENT ENSURES THAT INDIVIDUALS HANDLING HAZARDOUS MATERIALS DO NOT POSE A RISK TO PUBLIC SAFETY. WALMART COMPLIES WITH THESE REQUIREMENTS AS PART OF ITS HIRING AND TRAINING PROCESS.

PROCESS TO OBTAIN A HAZMAT ENDORSEMENT

STEP 3: COMPLETE TSA SECURITY THREAT ASSESSMENT

APPLICANTS MUST SUBMIT FINGERPRINTS AND UNDERGO A SECURITY THREAT ASSESSMENT BY THE TSA. THIS STEP IS MANDATORY TO RULE OUT ANY SECURITY RISKS ASSOCIATED WITH HANDLING HAZARDOUS MATERIALS.

STEP 4: RECEIVE THE HAZMAT ENDORSEMENT ON CDL

ONCE THE TEST IS PASSED AND THE SECURITY CHECK CLEARED, THE STATE DMV WILL ISSUE THE HAZMAT ENDORSEMENT, OFFICIALLY AUTHORIZING THE DRIVER TO TRANSPORT HAZARDOUS MATERIALS AS REQUIRED BY WALMART.

KEY COMPONENTS OF WALMART HAZMAT TRAINING
