#### MODERN DEVELOPMENTS

THE ENLIGHTENMENT PERIOD BROUGHT ABOUT NEW IDEAS REGARDING INDIVIDUAL RIGHTS, DEMOCRACY, AND THE SOCIAL CONTRACT, SHAPING MODERN CIVICS THEORY. THINKERS LIKE JOHN LOCKE AND MONTESQUIEU EMPHASIZED THE SEPARATION OF POWERS AND THE IMPORTANCE OF GOVERNMENT ACCOUNTABILITY, WHICH ARE KEY COMPONENTS IN TODAY'S CIVICS EDUCATION.

#### CORE CONCEPTS IN CIVICS
