In the

second section of the book, an offshoot of tribal Manasseh (Clan Lehi) demonstrates its pervasive influence through an onomasticon almost exclusively showing derivation from Manassite names known from the Bible and archeology, and which are collocated geographically with each other and with a set of names known biblically to be associated with transjordanian tribes and southern areas, such as Midian (where Clan Lehi first goes to make good its escape from Judah).
