MANY STUDENTS CHOOSE TO PURCHASE THEIR TEXTBOOKS FROM ONLINE RETAILERS. WEBSITES SUCH AS AMAZON, CHEGG, AND EBAY OFTEN OFFER COMPETITIVE PRICES, BOTH FOR NEW AND USED TEXTBOOKS. STUDENTS SHOULD COMPARE PRICES FROM MULTIPLE SOURCES TO ENSURE THEY ARE GETTING THE BEST DEAL. ADDITIONALLY, MANY ONLINE RETAILERS OFFER OPTIONS FOR QUICK SHIPPING, MAKING IT CONVENIENT FOR STUDENTS WHO NEED THEIR MATERIALS PROMPTLY.

By constructing a unified theoretical framework, this book attempts to open a new field of interdisciplinary research that should take globalizations 'from below' out of their current scholarly marginality.
